H. Old Business Discussion

- 1. Levy Request for 2015-16
 - a. Number of years
 - b. Amount
 - c. Roof replacement on all three large buildings?

It is Superintendent's recommendation that the District request the same maintenance and operations levy amount as we have levied for the past three years. Mr. Vian also would like to ask the patrons to approve this levy for two years, the same as our last levy, during elections to be held in March. He would also like to ask the voters to approve an additional \$400,000 to cover the costs of replacing the roofs on our three larger buildings – OES, OJSHS and TS.

The Homeowners' Exemption has gone from \$81,000 to \$89,000. With this change the cost to the tax payers would increase approximately \$30 per year.

I. Action Items

A motion to approve the First/Second reading of Policy 3400, with amendments, was made by Mrs. Jared, seconded by Dr. Robinson and approved unanimously.

After a lengthy discussion between the Board of Trustees, Superintendent Vian, OJSHS Athletic Director Jeff Wright and Timberline Principal Jason Hunter, Ms. Hardy made a motion to approve the first reading of Policy 3340. After further debate Ms. Hardy asked to "strike" her motion to approve the policy. All involved in the discussion decided to table this item until the October meeting, allowing everyone more time for additional research.

2. Alternative License for Peck Teacher

A motion to approve the Alternative License for Brenda Drobish at Peck Elementary was made by Mrs. Jared, seconded by Ms. Hardy and approved unanimously.
