The roof at Timberline Schools and Bus Barn will be replaced, the kitchen floor at Timberline will be repaired and Orofino Jr/Sr High School will have work done to prevent water seepage into the building.

Ms. Hardy said that she was going to visit with Dr. Raines to see how she recruits non-school age children (preschool). Administrators in attendance said that she posts flyers in the buildings and around town and she also publishes an announcement in the local newspaper.

A motion to approve the bid from Spokane Roofing was made by Mrs. Jared, seconded by Ms. Hardy and approved unanimously.

## 3. Alternative License Request for Gretchen Garrett

A motion to approve the Alternative License (Math) request for Gretchen Garrett was made by Ms. Hardy, seconded by Mrs. Jared and approved uananimously.

# 4. Budget Amendment of Amendment on March 20, 2017

A motion to approve the amendment to the budget amendment from March 20, 2017 was made by Ms. Hardy, seconded by Amy Jared and approved unanimously.

### 5. Appointment of Trustee
